Welcome to Birmingham!

The 46th Annual Meeting of the British Society for Paediatric Endocrinology and Diabetes will be held on 7-9 November 2018 at the Repertory Theatre in Birmingham.

The Programme Organising Committee, the local diabetes and endocrine teams as well as Bioscientifica look forward to welcoming you to Birmingham. We think you will agree using a venue that is in the centre of town will be convenient for access, and the panoramic views from the top of the new Library adjacent to the venue, are worth the walk up.

We have put together an exciting <u>programme</u> covering practical aspects of paediatric endocrinology and diabetes underpinned by robust science and key national and international trials. We have made the most of our local science and clinical expertise, particularly in DSD/adrenals, bone and rare diabetes; and also invited some world class speakers to present recent study outcomes, such as Trialnet and NESGAS.

We have again incorporated parallel sessions on both days – one with a diabetes and one with an endocrine flavour, aimed at the broad range of health professionals within these specialities. We have been keen to select varied but highly topical areas, allowing the programme to cover aspects of thyroid problems, growth, diabetes technology, and type 2 diabetes, always with an emphasis on the practical aspects of management. In place of meet the expert sessions, we have included 'State of the Art' lectures, but kept the question and answer sessions as part of these, on growth and NESGAS, and 20 years' experience in Metabolic Bone disease. These will be special opportunities to celebrate the massive contributions of Professors Jeremy Kirk and Nick Shaw to our Society and Paediatric Endocrinology.

The CME day on Wednesday 7th November will also appeal to people from a variety of backgrounds with a stimulating mixture of talks including sessions on managing obesity and techniques to maximise childhood and adult height.

The Scientific programme will be complemented by satellite symposia on clinical trial results (Wednesday 16:40-17:40), growth hormone (Thursday 07:45-08:45) and adrenal insufficiency (Friday 08:15-09:15).

Hopefully you will find time to explore the area including the famous Bullring Shopping Centre and Symphony Hall and we are sure that those attending the Thursday evening dinner at Birmingham Council House (adjacent to the conference centre) will have a great time socialising and dancing!

Trainee Update

RCPCH Progress Curriculum Problem with Tagging Transfer

As some of you may have discovered, there has been a problem with the migration of tags from the 2010 Generic Curriculum to the Progress curriculum in the ePortfolio, which should be completed for all trainees by the end of October 2018. The College has produced a document of apology and advised that these need to retagged manually. You do not however need to retag anything in your previously completed Levels. This should not affect other aspects of the curriculum, including the migration of the 2010 Paediatric Endocrinology and Diabetes curriculum. News from the Clinical Committee

Surveys

Further updates from the Clinical Committee

The Paediatric Endocrine Standards are currently available for review by BSPED members.

The Clinical Committee is reviewing the Rare Endocrine Tumour guidelines as they are released for consultation.

The Clinical Committee intends to start the next cycle of Peer Review towards the end of the year.

The Committee is continuing to work on a Delphi questionnaire to audit standard protocols for Glucagon Stimulation tests, Insulin Intolerance Tests (ITT) and the use of sex hormone priming for growth hormone testing amongst tertiary centres. This will be circulated to members shortly.

The impact reports are based on data from national audits, reports, survey and indicator frameworks that show the uptake of our guidance and quality statement measures.

Next steps for genomic medicine in the NHS - regulation, challenges for adoption and priorities for research

20 November 2018 - Central London

This seminar will bring together key stakeholders to discuss the next steps for personalised medicine and genomics.

Delegates will consider the main issues for the new NHS Genomic Medicine Service as it becomes fully operational in October - as well as the results of the <u>100,000 Genomes Project</u>, with the Project aiming to have completed sequencing by the end of the year.

Planned sessions will look at the work of the NHS Genomic Medicine Centres as they aim to deliver the pledge of 90,000 samples of DNA from patients and family members with rare disease and cancer by September 2018

- as well as the findings from the Common's Science and Technology Committee <u>report</u> Genomics and genome editing in the NHS.

Further sessions focus on next steps for education and training, following the continuation of the <u>Genomics</u> <u>Education Programme</u> and priorities for patients - looking at key issues for patients' data and ensuring public trust.
