The 47th BSPED Annual Meeting will be held in **Cardiff, at the City Hall** on **27-29 November 2019**. BSPED 2019 will be convened by Justin Warner, who has introduced a theme for this year's meeting: *"Working together, supporting expertise for a life without barriers"*.

Here are just some of the **highlights** from the [BSPED 2019 programme](#):

- **Inquisitor Session:** Meet the Expert: Professor Mehul Dattani will be questioned by Dr Tim Cheetham about a variety of clinical scenarios.
- **The Diabetes Debate:** Dr Rachel Besser and Dr Anuja Natarajan will debate "This House believes that continuity of care with doctors underpins optimal diabetes management in children and young people with diabetes".
- **CME Day:** Expert speakers will cover a wide range of topics such as investigation and management of 46 XY disorder of sexual differentiation, pituitary tumours, growth in small for gestational age, vulval skin disorders, hypopituitarism, talking to a child with DSD, promoting self-management in type 1 diabetes and diabetes technology update.
- **Diabetes Professionals Day:** Plenary sessions on practical diabetes, enhancing care, managing diabetes in special circumstances, diabetes trials and quality improvement.
- **Endocrine Main Meeting:** Plenary sessions on outcomes from endocrine disease and thyroid disease in children and a host of oral communications. Professor John Wass will give a guest lecture on 'The history of Paediatric Endocrinology'.

- **Nurses' Day for Endocrine Professionals:** This year there will be a lively multi-professional discussion on the emergency response to children with adrenal insufficiency. Renowned speakers will also be attending to present on the topical areas of growth in bone disorders, plus Duchenne muscular dystrophy.

These vacancies will arise due to the completion of the extended terms of office of Dr Justin Davies and Prof Jo Blair. Successful candidates will join the Executive Committee as Chair-elect and Secretary-elect (non-voting) following the AGM on Thursday 28 November 2019. They will then complete a 3-year term as Chair and Secretary starting from November 2020.



The successful candidates will be elected via an e-vote by members, not a ballot at the AGM.

Peer Review

The latest round of BSPED peer review conforming to the new [UK Standards for Paediatric Endocrinology](#) is now up and running. The Queen's Medical Centre in Nottingham was the first Centre to be reviewed in the new round. Growth Hormone Audit

We'd like to remind you about the BSPED National Growth Hormone (GH) Audit, and encourage you to submit your data on newly-prescribed GH in children < 16 years old. The aim of this rolling Audit is to monitor prescribing trends and compliance with NICE guidance. The GH Audit is now part of the BSPED Peer Review process. At Peer Review individual centre prescribing practices will be reviewed in comparison with national practices. You may choose to compare your current practice against UK data by downloading GH Reports through the [online members' area](#).

Please be advised that the DKA Calculator is currently unavailable while some essential maintenance is carried out to ensure it remains accurate when used with modern browsers.

Vacancy: 2 Clinical Fellows (middle grade) in Paediatric Endocrinology and Diabetes in Bristol

Applications are invited for 2 Clinical Fellow posts (middle grade) in Paediatric Endocrinology and Diabetes at the Bristol Royal Hospital for Children, to commence from November or as soon after as possible for 12 months.

These posts will provide middle grade level clinical services with Consultant support including delivering outpatient clinics and day-time management of inpatients and ensure the post holders gain invaluable experience and training in paediatric endocrinology & diabetes with subspecialist training by working with a specific subspecialist teams (attending clinics, MDTs etc). This will include with protected time to develop either a research or quality improvement project, one with the Endocrine Bone Team and the other with either DSD , late effects, obesity or diabetes teams.

These posts will be new contract compliant on commencement and will take part in the Paediatric sub-specialties on call rota (currently 1 in 9) on a 50% basis (ie both posts sharing a single slot on the rota). The post holders will work alongside 1 or 2 registrars and one ST1-3 and will participate in exactly the same timetable and training opportunities as training post holders.

There is an active educational programme within the department and hospital, with weekly teaching sessions, journal clubs and monthly simulation sessions. Support for study leave will be given and participation in research and audit activities is strongly encouraged.

Vacancy: Non-Clinical Lecturer in Endocrinology at UCL GOS Institute of Child Health London

Applications are invited for a Lecturer post based in the Genetics and Genomic Medicine (GGM) Research and Teaching Department at the UCL Great Ormond Street Institute of Child Health. The post is open ended, with initial funding provided by Great Ormond St Children's Charity (GOSHCC) for 5 years to support capacity building in the area of Paediatric Endocrinology. It aims to attract the best and brightest in the new generation of non-clinical researchers using molecular, cellular and stem cell approaches to the study of Endocrinology.

This Lecturer post is a strategic appointment in order to maintain the ICH position as leaders in endocrine research both nationally and internationally, and to develop novel translational research programmes based on the latest emerging technologies such as iPSC, single cell transcriptomics, and CRISPR/CAS-9 genetic manipulation for patient benefit. We invite applicants for a full-time retirement replacement substantive consultant post in the Regional Paediatric Endocrinology and Diabetes services at Bristol Royal Hospital for Children, UHBristol, recognised by the European Reference Network as a specialised centre for both Rare Endocrine and Rare Bone disease.

The post holder will join the existing team of 3.6 full time consultants and endocrine MDT who deliver a comprehensive Specialist Paediatric Endocrinology service to the South West Region through a network of regional shared-care clinics, and the large paediatric diabetes MDT which includes an additional HEFC funded University of Bristol Consultant and 2 general paediatricians with an interest in diabetes.

Bristol has the largest Paediatric Diabetes clinic in the UK (patient numbers=500). The post-holder will also be involved in the development and delivery of the nationally commissioned, NCG funded complex Osteogenesis Imperfecta services and metabolic bone service. We maintain excellent links with our subspecialist and adult colleagues with specialist referrals, joint clinics, an evolving transition pathway and an active research programme. The successful applicant will have a strong clinical commitment and have clinical, research and administrative skills that complement those of the existing team. Applicants must be eligible for full registration to practice with the GMC and hold or be within 6 months of CCST or equivalent in Paediatric Endocrinology and Diabetes SPIN. Stakeholder registration is open for all stakeholders, including patients, carers, service users, members of the public, clinical staff, provider organisations working in specialised services and voluntary sector partners.

It is the registered stakeholders who are automatically sent new specifications and policies for comment.

You can sign up for one or more Clinical Reference Groups (CRGs). You would at least need to sign up for paediatric medicine and specialised surgery in children to receive the testing for the DSD specification and policy when this is carried out.
