DKA Guideline

An <u>updated guideline for the management of DKA in children and young</u> <u>people</u> is available, having been revised by the BSPED Special Interest Group in diabetic ketoacidosis following a series of meetings. The relatively limited evidence regarding the management of DKA has been reviewed. Where there is appropriate evidence these guidelines have been based on such evidence. For many aspects of the management of DKA the evidence base is limited and where there is limited evidence, consensus recommendations have been consolidated.

Wolfram syndrome is a monogenic diabetes disorder, diagnosed if diabetes mellitus and optic atrophy occur in children under 16 years of age. There are also rarer, partial forms of the syndrome.

Do you have a child with this syndrome in your clinic?

If so, please do get in touch. There is an NHSE national MDT service based in Birmingham that provides annual review by all relevant specialties, screening for complications, and advice on management. There is also an ongoing international clinical therapeutic trial to slow the progression of the disease.
