## **News from the Clinical Committee**

### **Update to BSPED Guideline: BSPED UK Consensus National Guidelines for Sex Hormone Priming for Growth Hormone (GH) Stimulation Testing**

Please note that an update has been released on the website. Please be aware that in accordance with MHRA recommendations the Guidelines no longer suggest the use of stilboestrol. Please help and disseminate to your colleagues by visiting the [BSPED website](#).

### **NICE Guideline: Maternal and child nutrition: nutrition and weight management in pregnancy, and nutrition in children up to 5 years**

This guideline covers nutrition and weight management in pregnancy for anyone who may become pregnant, is planning to become pregnant or is already pregnant, and nutrition in children up to 5 years. Care of babies and children born preterm or with low birth weight is not covered. The guideline does not give detailed advice on what constitutes a healthy diet. ### **NICE Guideline: Overweight and obesity management**

This quality standard covers prevention, behavioural management, assessment, and treatment of overweight, obesity and central adiposity in children and young people aged over 2 years, and adults. This includes those with established comorbidities, and those with risk factors for other medical conditions. It describes high-quality care in priority areas for improvement. ### **Position statement: 'BSPED recommendations for the use of once-weekly long-acting growth hormone therapy in children with growth hormone deficiency'**

The BSPED Growth Disorders Special Interest group (SIG) is delighted to highlight a new updated document on LAGH.

This document originally developed in 2024 has been updated to include guidance for both long-acting growth hormone (LAGH) preparations now licenced and approved by NICE -somatotropin (Ngenla®) and

somapacitan (Sogroya®) for the treatment of growth hormone deficiency in children and young people aged three years and over.

This revised position statement aims to summarise the latest data and provide recommendations on dosage and surveillance for clinicians prescribing LAGH. It will be updated as new LAGH preparations are accessible to patients in the UK.

### **NICE Guidelines**

The Clinical Committee has submitted comments on the following NICE consultations in the recent months and will keep you informed of the outcomes:


- Rare Disease QS
- Obesity (acquired hypothalamic, 4 years and over) - setmelanotide
- Polycystic ovary syndrome: assessment and management

Note the appraisal for **Vosoritide for treating achondroplasia in people 4 months and over** has been suspended as BioMarin has advised that they are no longer pursuing a Marketing Authorisation Application from the Medicines and Healthcare products Regulatory Agency for this indication at this time.

## Including your survey in the newsletter

If you would like to include a survey in a BSPED newsletter to encourage responses from BSPED members, it must first be reviewed by the BSPED Clinical Committee.

- Your survey should be reviewed by the Clinical Committee at a stage where it can still be amended and before it is circulated elsewhere.
- The Clinical Committee meets four times per year and the deadlines for submission of agenda items are published in the newsletter.
- Your survey should be submitted to [the BSPED Office](#), in Word format.
- The introduction to the survey should explain its purpose and the closure date of the survey.
- The survey will either be approved for inclusion in the newsletter as it is, or feedback will be provided to the author.
- Survey owners should agree to report their findings back to the Clinical Committee 6 months after the survey closes.
- The BSPED should be acknowledged in any output (guidelines, publications, presentations, etc.) resulting from the survey and the BSPED Office informed of the output.

## Process for endorsement and development of clinical guidelines and standards

The BSPED Clinical Committee is committed to supporting its members in creating robust, evidence-based guidelines. The Committee is not resourced to independently develop national clinical guidelines, but will serve as a key stakeholder in guideline development relevant to paediatric diabetes and endocrinology and will take responsibility for endorsing guidelines produced by other organisations. **In order for a standard or guideline to be endorsed by the BSPED, the procedure set out on our website must be followed.** This involves the early involvement of the Clinical Committee in the development of the document. ### **The UK Islet Autoantibody Registry**

The UK Islet Autoantibody Registry (UKIAB), funded by Diabetes UK, is now open. With the aim to bring together individuals with positive islet autoantibodies, and those who are not on insulin, identified through NHS testing or research programmes. The Registry will provide a foundation for research that enhances early recognition, prevention, and care for those in the early stages of T1D. Your help in raising awareness is essential to its success.

Patient self-registration: via [www.ukiab.org](http://www.ukiab.org). Any UK child or adult who has had a positive islet autoantibody test, whether through NHS care or research are eligible. Free confirmatory re-testing is available, and provides accurate risk prediction, by using appropriate thresholds through the UKIAB antibody laboratory.
