A well-known and respected member of many national and international societies and has an international reputation as an outstanding Paediatric Endocrinologist. A previous Executive Committee member of the BSPED he has attended annual meetings since 1985 and lectured and presented at many of them. He was a consultant paediatrician at GOSH and established diabetes and bone services with major contributions to the 'Twinkle' database National Diabetes Audit and 'SWEET' project. He described Triple A (Allgrove) syndrome and conducted groundbreaking research leading to the discovery of parathyroid hormone-related hormone (PTHLH/PTHrP). He is also renowned for his ability to entertain from memory, with an extensive repertoire of very amusing tales.

## News from the Clinical Committee

Position statement: 'BSPED recommendations for the use of once-weekly long-acting growth hormone therapy in children with growth hormone deficiency'

The BSPED Growth Disorders Special Interest group (SIG) is delighted to highlight a new updated document on LAGH.

This document originally developed in 2024 has been updated to include guidance for both long-acting growth hormone (LAGH) preparations now licenced and approved by NICE -somatrogon (Ngenla®) and somapacitan (Sogroya®) for the treatment of growth hormone deficiency in children and young people aged three years and over.

This revised position statement aims to summarise the latest data and provide recommendations on dosage and surveillance for clinicians prescribing LAGH. It will be updated as new LAGH preparations are accessible to patients in the UK.


#### Use of and comments regarding guidelines



#### Including your survey in the newsletter

#### Process for endorsement and development of clinical guidelines and standards

The BSPED Clinical Committee is committed to supporting its members in creating robust, evidence-based guidelines. The Committee is not resourced to independently develop national clinical guidelines, but will serve as a key stakeholder in guideline development relevant to paediatric diabetes and endocrinology and will take responsibility for endorsing guidelines produced by other organisations. In order for a standard or guideline to be endorsed by the BSPED, the procedure set out on our website must be followed. This involves the early involvement of the Clinical Committee in the development of the document. The Endorsement Process is available on our website.

#### In memory of Dr. Mike Ryalls

The South Thames Paediatric Endocrine Group (STPEG) are very sorry to pass on to the BSPED the extremely sad news that our dear friend, Dr Mike Ryalls, passed away on October the 25th surrounded by all of his family. He had a relatively short illness diagnosed while he and his wife Caroline were in Australia earlier this year.

Mike was a founder committee member of the STPEG from 1996 and continued to play a very active role up to his retirement. He was also an active member of BSPED and he was the last winner of the BSPED Golf Trophy in Winchester in 2014. Mike was a general paediatrician with a special interest in diabetes and endocrinology at the Royal Surrey County

Hospital, Guildford for many years and he also worked at the Royal Marsden Hospital on the late endocrine effects of cancer treatment. Before that, he was a research fellow at the Royal Marsden investigating the endocrine consequences of bone marrow transplantation and also spent time in endocrine Training in Melbourne, Australia. He had many high quality scientific publications covering a wide range of subjects.

Mike will be remembered for his cheerful good humour and was always excellent company. He had many other interests outside medicine including skiing, golf and, after retirement, Kitesurfing! Our thoughts go out to his wife, Caroline, his children, Rebecca and James and to his extended family.

#### Prader-Willi syndrome: guidance for children and transition into adulthood

*Endocrine Connections* have recently added consensus guidelines for clinicians supporting patients with Prader-Willi Syndrome to their website.

This consensus statement is intended to be a reference document for clinicians managing children and adolescents (up to 18 years of age) with PWS. It considers the bio-psycho-social domains of diagnosis, clinical assessment, and management in the paediatric setting as well as during and after transition to adult services.
